Call Out Authoritarianism Clearly

Publish public-facing scholarship, including op-eds, blogs, and books, that directly challenges MAGA ideology.

Defend universities from political attacks designed to silence critical perspectives on history, race, and democracy, such as anti-CRT laws. Push back against deplatforming efforts that seek to ban discussions on systemic oppression, LGBTQ+ rights, or fascism. Support scholars and students targeted by right-wing harassment.

Mobilize Education Against Disinformation

Integrate media literacy and propaganda analysis into courses. Teach students how to recognize and challenge misinformation spread by MAGA-aligned networks. Publicly debunk right-wing conspiracy theories like the "Great Replacement" and election fraud lies.

Bridge the Gap Between Academia and Activism

Work with grassroots movements to support democratic engagement, racial justice, and labor rights. Participate in public forums, protests, and advocacy efforts to combat creeping authoritarianism. Collaborate with journalists and fact-checkers to amplify factual, research-backed narratives.

Defend Democratic Norms & Institutions

Advocate for voting rights, fair elections, and accountability for political violence, such as the January 6 insurrection. Use historical comparisons, such as 1930s fascist movements, to warn about the dangers of Trumpism. Support policies that combat far-right radicalization, such as regulating online extremist networks.

Create & Support Alternative Narratives

Challenge MAGA's nostalgic myth-making with a more accurate, inclusive history of America. Highlight progressive patriotism—one that embraces democracy, civil rights, and pluralism rather than exclusion and white nationalism. Promote visions of a just future that counter the despair and fear fueling far-right movements.

 - Expose fascist ideologies by studying their historical roots, tactics, and consequences.
 - Debunk misinformation with fact-based research on nationalism, authoritarianism, and propaganda.
 - Analyze contemporary threats by tracking the rise of far-right movements and their societal impact.
- 2. Teaching & Curriculum Development
 - Incorporate anti-fascist history into syllabi, emphasizing the dangers of totalitarianism.
 - Foster critical thinking to help students recognize and resist manipulative rhetoric.
 - Discuss real-world case studies showing how fascism operates in different contexts.
- 3. Public Engagement & Advocacy
 - Write for the public through op-eds, blogs, and accessible books to educate beyond academia.
 - Host public lectures & debates to promote open discourse against extremist narratives.
 - Support journalists & fact-checkers by providing historical and political context.
- 4. Institutional Action & Solidarity

- Defend academic freedom against political attacks that suppress dissenting voices.
- Strengthen diverse & inclusive spaces to counteract exclusionary ideologies.
